- 1.3. Additional products to complete building finish solutions shall meet the performance requirements within the appropriate Division. They are to be presented for review and approval to the University of Minnesota, University Architect and/or designee.

Executive Summary: Design Intent

The purpose of the University of Minnesota Interior Finish Standards is to manage and support financial stewardship and aesthetic consistency at the University of Minnesota. Solutions are managed through Capital Project Management and created to achieve key overall objectives:

- define a University aesthetic
- address product performance
- manage costs
- provide equitable vendor/marketplace opportunity

A consistent quality aesthetic demonstrates the University's commitment to students, visitors, and staff.

Interior finish standards create a neutral environment and allow users to move in and out of space assignments without significant impact to department identity. These neutral finish palettes afford users the opportunity to personalize their space through art, accent furniture, and signage.

Performance standards are determined through a collaborative review and understanding of long-term facility maintenance as well as daily custodial cleaning requirements.

Project efficiency and cost reduction are achieved through the reduction of churn time related to the development of customized project palettes.

Guiding Principles

These interior finish palettes are to be used for small scale construction and remodeling projects as well as work orders within the University of Minnesota, Twin Cities campuses.

The Capital Project Management interior finish palettes are transitional solutions expressing the University’s current and evolving aesthetic.

Buildings are classified into 3 “era” categories with palettes created to meet the building interior needs. A supplemental “Building Classification” list prescribes each building’s category on the Twin Cities Campuses. Included are photographic examples that demonstrate these categories. Within each category, a respective series of palettes are utilized to complete the solution.

Categories	Number of Palettes
Historic	3
Modern	5
Contemporary	3

Exceptions for required implementation of these standards exist for:

- Athletics freestanding facilities
- University Dining Service establishments
- Housing & Residential Life dormitory facilities
- Office of Classroom Management large classrooms/ auditoriums

Projects that encompass *Public Space* and *Historic Buildings* are to be reviewed in collaboration with the University Architect.

New building, large-scale construction and renovation projects will develop under the direction of Capital Project Management and the University Architect, consistent with Administrative Policy. That team will collaborate with contracted design firms to integrate over-arching concepts and elements of these interior finish standards, yet expand the design aesthetic. This attention to new design opportunities will continue to cultivate the diverse and unique University building inventory.

Implementation

Interior Finish Standard documentation materials are intended for field use by all staff and end users requesting or directing interior work on the campuses. This includes: Capital Project Management, Facilities Management, University Construction Staff, and contracted consultants. End users are to contact these organizations through the project request system to review options for their project.

Interior Finish Standards are published in the University website of Capital Project Management; Building Standards: Division 09 - Interior Finish Standards.

Tools for design teams are available as:

- Interior Finish Standards Manual (web)
- Palette options (web)
- Finish sample palettes (box sets)

These standards are developed for use in the following environments:

- offices
- department common areas
- conference rooms
- teaching / small classrooms

Within these environments, the Standards encompass:

- wall paint colors
- flooring materials
 - carpet
 - hard surface
 - walk off carpet
- vinyl floor base with door/window frame paint
- cabinetry and counter tops
- wood finish guidelines
- ceiling finish guidelines

Public Space to be reviewed in collaboration with the University Architect include:

- building lobbies/atrium
- major building corridors
- public gathering spaces
- elevators/stairwells/vestibules
- restrooms/showers/locker rooms

Exception requests for product used outside of these standards are to be submitted through the website of Capital Project Management; Design Standards Forms: Exception Request - Interior Finish Standards.

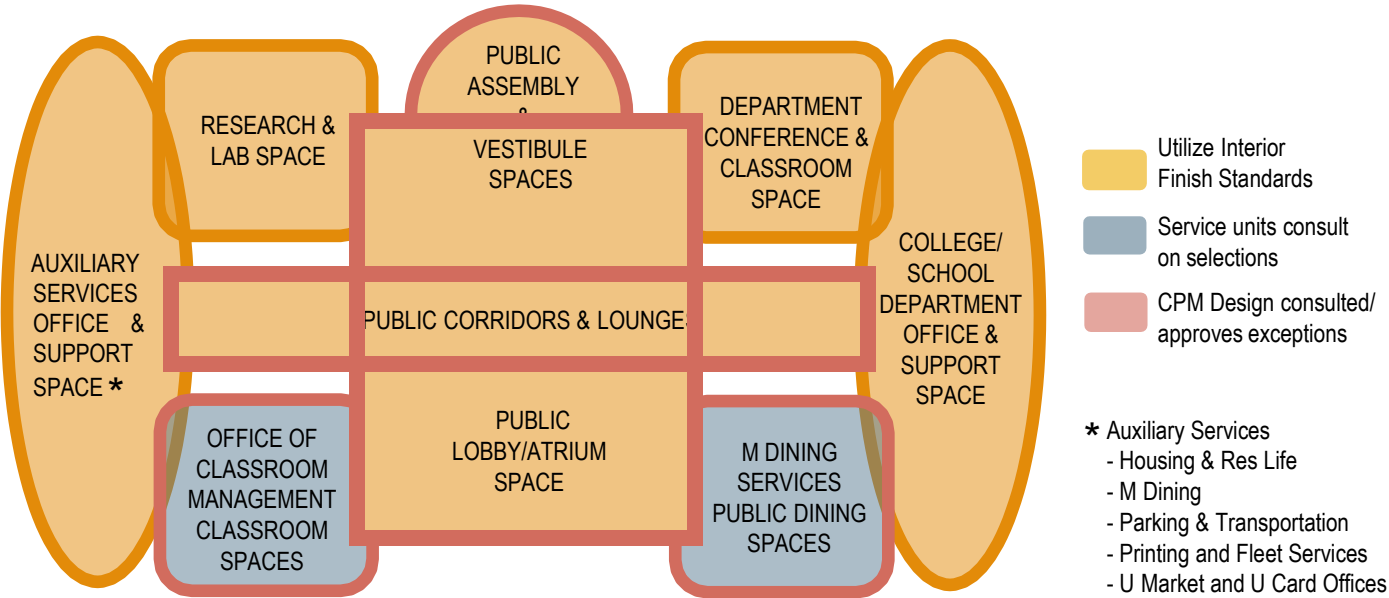

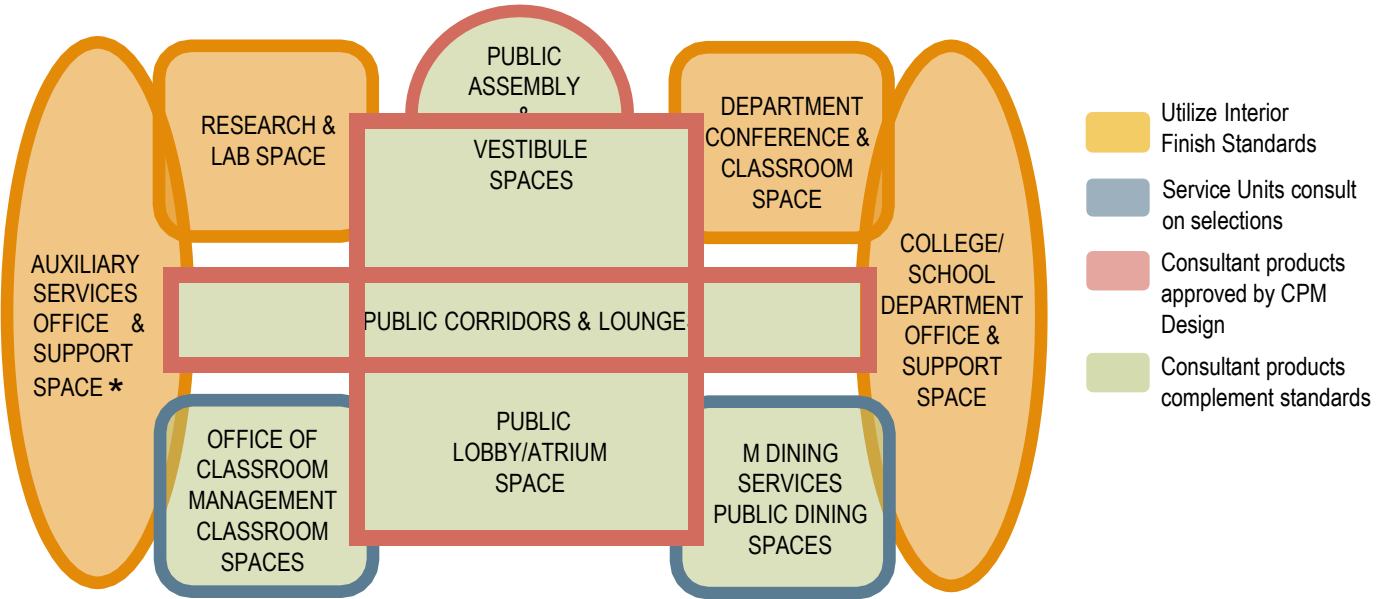
Project Utilization

 - 1 wall: 1 accent color
- Reference the paint appendix for hard ceiling paint color, matching wall protection products/colors, detailed information on floor products and manufacturer reps.
- Hollow metal door frames and the interior side of painted exterior window frames will be semigloss alkyd paint in the following options:
 - standard neutral color paint,
 - or
 - match of the selected standard vinyl base
- Metal exterior window frames to remain existing
- Each building's predominant architectural wood tones (primarily doors/frames, built-ins, etc.) are to be retained.
- Building elevators are to be finished in a combination of building architectural wood tone laminate, brushed stainless reveals and hand rails. Laminate panels trimmed with top and bottom U-channels. Floors in standard rubber resilient floor product.
- Building occupants are not to select wood finishes for architectural elements. They may provide a variation of wood tone through department purchased furniture.
- Acoustic lay in ceiling must match Facilities Management's respective building standard tile or upgraded product to accommodate Facilities Management District's building inventory needs.
- Non-standard finishes must be submitted through the on line exception request to the Capital Project Management, Design Project Manager. Link found at <https://cpm.umn.edu/design>. Requests will be assessed and reviewed in conjunction with the University Architect.
